# Town of Buxton Planning Board Minutes April 28, 2025

Members present: Jere Ross, Scott Warchol, Roger Tracy, Heath Knight and Craig Lefebvre. Also attending on behalf of the town: Patti McKenna, Code Enforcement Officer and Roxanne Gardner, Code Enforcement Secretary. Other attendees: Henry W. Huntley, Cliff Thomas, Adam Maravis, Troy Thibodeau, Todd Libby, Tonja Lefebvre, Gabor Korthy.

### Chairman Jere Ross called the meeting to order at 7 pm

### **Appointments:**

Henry Hess RLA- OBO RAAP Industries LLC -Subdivision Amendment Application- for a 3 lot Subdivision- Commerce Drive- Map 9 Lot 27-1-2

The applicant was not present. The Board discussed the site walk and all agreed everything looked good. Patti reminded the board that there needs to be a second reserve septic area on the plans for the lots that have poorly drained soils. Scott added that the test pits have to be added to the lots on the plan. Scott Warchol made the motion to schedule the public hearing for May 12 at 7 p.m. Heath Knight seconded. The motions passed with a vote of 4-0-1 with Roger Trac abstaining.

## Application for Conditional Use- Todd Libby - Libby's School of Taekwondo - 400 Narragansett Trail-Map 10 Lot 1 & 2

Todd Libby was present to explain his application. He is asking to provide classes during the hours of Monday through Friday from 10 a.m. - 8 p.m. The ordinance requires one parking space for every 100 square feet. The room is  $12 \times 28$ . 3.5 spaces are required. They have 4 spaces dedicated to this section of the building with one handicap space by the ramp. Craig made a motion to schedule a site walk for May  $5^{th}$  at 5:30pm. Heath seconded the Motion. Motion passed with a vote of 5-0 in favor.

**CMP- Email for modification - notifying the Town of extended work hours.** Troy Thibodeau and Adam Maravis were present representing CMP. They presented the request for extended hours as follows:

Mondy -Friday April 28- June 26 from 7 am to 7 pm / Saturdays — May 3 — June 28 7 am -5 pm Sundays — June 15 and June 22-7 am -3 pm / No work on Memorial Day weekend May 24, – 26 Saturday, Sunday and Monday.

They clarified that the Sunday work is when ISO New England has scheduled a power shut down to tie the wires to the substation. They have no control over those dates. Everything has to be done before that. Or this puts the project off possibly into next year. ISO New England picked these days in the spring because they are low useage days. If the project isn't ready for June 15

and 22, the next low useage days will be late fall. This Sunday work will be in the substation and will be considered quiet work.

They are asking for the extra hours for drilling until May 16<sup>th</sup>. They have to be done with drilling by then to be on schedule for the Sunday work. They have to bring in a third drill to get this completed by the 16<sup>th</sup>.

The rest of the extended hours asked for is quieter work than the drilling.

The Board took a straw poll of the members whether to agree to the extended hours. Craig, Roger and Heath were in favor of allowing it. Scott and Jere were not in favor.
